Passed fuel tank pressure test to 3.5 p.s.i. IAW FAR 23.965 (a) (1). Recovered with F.A.A. approved Poly-Fiber Stits© covering process IAW Chap. 2 (repair & refinishing fabric surfaces), applied; 3 coats Poly brush, 4 coats Poly spray, 2 coats Aero-thane Junuae white. Reinstalled right wing IAW Champion Aircraft 7ECA service manual Sec 4-15.
